EVENTS BROADCAST ON THE WINTERSSET HUSKY



- W Digital Network (WDN) is a for-profit entity providing broadcast content to the Winterset Huskies YouTube channel at no charge to the Winterset Community School District (WCSD) in coordination with AHV Productions. WDN has an exclusive video agreement to broadcast select activities for WCSD. We are not affiliated with or funded by the WCSD and sponsorship fees do not benefit the WCSD. Our broadcasts are approved by the WCSD School Board and Administration. Sponsorship fees are not considered a charitable donation. When possible, we employ students as production staff and offer paid training positions for students.
- eps, jpeg or png are preferred formats for logos and pictures supplied by sponsors. Pre-produced videos in mp4 format can be provided for re-broadcast if 30 seconds or less in length. Video ads created by WDN will use supplied logos and pictures, along with pictures or video created by WDN, audio only ads will be created for away games.

Post-Season sponsorship is invoiced separately to a sponsor after completion of the additional games. Post-Season fees can vary, depending on how many sports may qualify and if the host school allows a video stream.

-IGHSAU Post-Season Girls basketball will be an additional cost per game - \$25-1st Round and \$40-Finals

-IHSSA Post-Season Boys Basketball will be an additional cost per game - \$10-All Rounds

The WDN to provide ad copy for approval by the sponsor. The approved ad copy shall be shown and read during the events as specified in the sponsorship agreement for live viewing purposes. Replay availability of the content is at the discretion of the WCSD and the host school. The produced ad copy is the property of the WDN and the WDN is given permission by the owner of logos and trademarks for their use within the ad copy. The WDN operates under an agreement with the WCSD as the exclusive video content provider for select activities and is also governed by the approval of the IGHSAU and IHSAA to broadcast specific events. WDN has the right to refuse sponsors or content that may contain items such as tobacco, alcohol, immorality or similarly prohibited content and is held harmless in cases of ads being denied by either the WDN or WCSD. The WCSD decides the content delivery location such as YouTube or similar locations. If there is a delay or cancellation of listed events, alterations to the agreement can be arbitrated in good faith by both parties. The W Digital Network is produced by AHV Productions, a subsidiary of E-Vision Systems LLC, an Iowa registered entity, governed by the laws of Iowa.

No ad content can be displayed during a broadcast unless a signed agreement has been executed by a Sponsor. Sponsor agrees to payment terms of NET 15 days after invoice date for the regular season sponsorship fee of \$250 and post-season events. All payments to be made in check or credit card to the W Digital Network.
